RESOLUTION NO. R1 SERIES 2021**

A RESOLUTION AUTHORIZING THE CITY OF WOODLAND HILLS TO ENTER INTO A FRANCHISE AGREEMENT WITH SPECTRUM MID-AMERICA, LLC GRANTING A TEN (10) YEAR, NON-EXCLUSIVE FRANCHISE FOR A COMMUNICATIONS SYSTEM WITHIN THE CITY LIMITS OF WOODLAND HILLS

WHEREAS, by Ordinance No. 3 Series 2020; the City of WOODLAND HILLS created a ten (10) year, non-exclusive franchise for a communications system within the city limits of WOODLAND HILLS and

WHEREAS, the City of WOODLAND HILLS offered at bid a non-exclusive communications franchise pursuant to Ordinance No. 3 Series 2020; and

WHEREAS, Spectrum Mid-America LLC ("hereinafter "Charter") has submitted a bid for a communications franchise, in accordance with the terms and conditions reflected in Ordinance No. 3 Series 2020; and

WHEREAS, the City of WOODLAND HILLS has reviewed Charter's bid, and wishes to grant a non-exclusive communications franchise to Charter by entering into a franchise agreement with that company;

NOW THEREFORE, BE IT RESOLVED by the City Commission of the City of WOODLAND HILLS, that the Mayor is hereby requested and authorized to enter into a franchise agreement with Charter for a ten (10) year, non-exclusive franchise, the terms of which are subject to the provisions of Ordinance No. 3 Series 2020.

ORDINANCE NUMBER 1 SERIES 2021

AN ORDINANCE RELATING TO;

THE ESTABLISHMENT OF AN AD VALOREM TAX RATE FOR THE CITY OF WOODLAND HILLS, KENTUCKY FOR THE FISCAL YEAR BEGINNING JULY 1, 2021, AND ENDING JUNE 30, 2022, AND ADOPTING THE JANUARY 1, 2021 JEFFERSON COUNTY, KENTUCKY ASSESSMENT AS THE CITY OF WOODLAND HILLS ASSESSED VALUES.

BE IT ORDAINED BY THE CITY OF WOODLAND HILLS, KENTUCKY:

- SECTION I. That the tax rate for the City of Woodland Hills, Kentucky for the Fiscal year beginning July 1, 2021, and ending June 30, 2022, is hereby fixed at the rate of twelve (12) cents per One Hundred Dollars (\$100.00) of assessed property value.
- SECTION II. That all taxes collected shall be paid to the general fund.
- SECTION III. That all real and personal property having a situs within the City of Woodland Hills, Kentucky, on the assessment date of January 1, 2021, shall be subject to assessment and taxation for City purposes, unless exempt from taxation by the Constitution and the Statutes of the Commonwealth of Kentucky.
- SECTION IV. That the tax assessment date shall be January 1, 2021; that the assessment shall be the annual assessment as provided by KRS 132.285.
- SECTION V. That the fiscal year for the City of Woodland Hills, Kentucky, shall be from July 1, 2021 to June 30, 2022.
- SECTION VI. That the City Clerk shall compile and mail tax bills on or after the 1st day of October, 2021, to all those subject to tax.
- SECTION VII. That there shall be allowed a discount or credit of two percent (2%) for tax bills paid on or before December 1, 2021.
- SECTION VIII. That there shall be added a penalty of ten percent (10%) to any tax bill unpaid by January 1, 2022.
- SECTION IX. That in addition to the penalty set out in Section VII hereof, there shall be added interest at the rate of six percent (6%) per annum to all bills unpaid as of January 1, 2022.
- SECTION X. That this Ordinance shall take effect and be in force immediately upon its passage and publication.
